PACKAGING

25 kg net weight each, poly-lined, multi-wall paper bags. Packed under modified atmosphere.

STORAGE CONDITIONS

Product should be stored at cool (around 15 – 25 °C) and dry conditions (65% relative humidity). Do not expose to direct sunlight or strong odours.

SHELF LIFE

18 months from date of production when sealed and stored under the indicated conditions.
